### Guide to IRS Data Retrieval

This sheet is a guide to help you through the process of updating your FAFSA, using the IRS Data Retrieval Tool. Login into the FAFSA website, [www.fafsa.gov](http://www.fafsa.gov), click on “**Make FAFSA Corrections**” and enter the student’s PIN and Password. Review all information in the first three sections to make sure all information is correct.
