### From the Secretariat

Message Posted June, 2008

Dear IHREC members,

For those of us in North America and Europe it is the end of the academic year. For academics the end of lectures and exams allows for time for research, reading and reflection. Accordingly let me take this opportunity to reflect and recount some of the Consortium activities that have come to my attention in the last six months.

As is true for so many of our members, my year has been particularly busy. Since December I have visited members and participated in IHREC events in Sri Lanka, India, Canada, Romania, Bulgaria, Kosova, Albania, and California. The experience of working with our Consortium partners further convinces me that the pursuit of human rights education remains vital with students and activists, along with educators active in bringing the promise of the respect and understanding of human rights closer to reality.

At the end of three years of my four year term I have concluded that while much has been done by Consortium in the pursuit of human rights education there is much more to be done. This last year of my term will be dedicated to the sustainability and expansion of the IHREC. I look forward to working with our Consortium partners to continue to work for the accomplishment of our mission- the promotion of "...education, collaboration, and research on human rights at the national, regional, and global levels."

Among the many successes of our cooperative efforts was a recent decision by University of Mumbai (India) to make human rights a compulsory course in all the University's colleges. The efforts of the Mumbai Initiative for Human Rights Education (MIHRE), a broad coalition of human rights educators and advocates, helped bring about this accomplishment. MIHRE was established through the Institute of Community

Organsation for Research (ICOR), an IHREC partner and member. The MIHRE's is an effort resulting from the IHREC activities in India. IHREC VP and MIHRE President, Allwyn D'Silva, was quoted in a recent Mumbai article, "Our objective is to build a humane society in which all women, men, youth and children acknowledge, respect and enjoy human rights as well as make constant and special endeavours to promote a human rights culture." The efforts in India by the MIHRE and our Indian partners should inspire human rights educators in our Consortium to work cooperatively to achieve our goal of bringing the human rights message to larger and broader sectors of society. The possibilities are enourmous, but require the resolve and commitment of human rights educators within and out of the IHREC. The very purpose of our Consortium is to encourage cooperative efforts and I trust we will continue to look for new and creative activities to further our mission.

This year we will be honoring the sixtieth anniversary of the Universal Declaration of Human Rights. We should be ever mindful of its inspirational challenge; "that every individual and every organ of society...shall strive by teaching and education to promote respect for these rights and freedoms."

In that light I hope our members will be planning appropriate events to celebrate this important anniversary. If you have already made plans we would be happy to share the information with our membership. If we can provide other assistance in your celebration or activities please let us know.

Information such as the publication of new books, lectures, awards, promotions, training programs, etc. that you feel would be of interest to Consortium members are welcomed. While the Secretariat will of course continue to post the information on the web page, it would be useful if I could include it in this message.

Below is some recent information that has been received:

### Africa:

IHREC VP and treasurer, **Michael McGowan of St. Thomas University**, (Fredericton, New Brunswick, Canada), will travel to Accra, Ghana to attend the learning Africa 2008 conference in late May. He has been invited to speak at one of the sessions on the subject

of Human Rights Education in the 21<sup>st</sup> Century. While in Ghana he plans to meet with a number of university officials from various countries throughout Africa on the importance of university human rights education, research, and of course the work of the IHREC.

Michael has already established contacts in Liberia, Guinea, Mali and Sierre Leone. Six of his human rights students are currently working in those countries engaged in education, development, and child soldier rehabilitation.

The IHREC Executive Board has repeatedly discussed the need to seek membership in Africa. Michael's visit is consistent with our plan to further increase human rights education on the African continent.

### Asia:

An International Seminar on Human Rights in Conflict Situations was held in Colombo, Sri Lanka from the 11th until the 13<sup>th</sup> January, 2008

The Center for the Study of Human Rights, (CSHR) of the University of Colombo organized an international seminar held at the Hotel Renuka, Colombo, Sri Lanka.

IHREC member Professor Ravindra Fernanado along with others from Sri Lanka, organized the event with participation coming from India, the USA and elsewhere. Among the speakers was the American Ambassador and prominent human rights experts.



The three day event was well attended and very productive. The participants included academics, human rights lawyers, activists and journalists. The discussions occurred during the announcement of the suspension of the ceasefire of the on-going Civil War and were pertinent in light of the violence that began to escalate during the conference proceedings. One outcome of the meeting was a decision to organize a conference dealing with the prohibition of torture to be held in the subcontinent in 2009.


NGO Anubhav. Ms Elizabeth Kaufman, Director of AIRC and the chief guest on the closing day gave certificates to the participants.
