

Utica College Payment Guide Graduate Students FALL 2018

Utica College's Payment Plan for Ground Graduate students allows you to pre-register for Fall and pay your tuition in five (5) scheduled payments (see calendar below). There is a \$75 fee to enroll in the Payment Plan.

• If you opt for the Payment Plan for the Fall 2018 Semester, please click *Enroll in the Fall 2018 Graduate Campus Payment Plan. Please note, enrollment in the Fall Payment Plan opens on June 18, 2018.

*Our secure payment site **CANNOT** do automatic payments from your bank account nor your credit card. You must go into the payment site and initiate the payment each time. It will, however, give you the option to save your bank account or credit card information if you wish to do so.

Health Insurance Waiver

All full-time students are required to carry Health Insurance. A charge of \$789.750 will be applied to your bill at the time of full-time registration. If you have private health insurance, and wish to waive the charge from your bill, you must log on to: http://www.haylor.com/college/utica-college/. The waiver period opens on June 1, 2018 and the deadline to waive the charge is September 16, 2018. Please note that information you provide regarding your insurance will be verified. Students who have been found to not have health insurance will automatically be re-enrolled in UC's Health Plan and will be charged accordingly.

You can open a Book Line Of Credit (BLOC) for the semester if:

- you have filed a valid 2018-2019 FAFSA (www.fafsa.ed.gov)
- your Title IV authorization has been completed and accepted (www.utica.edu/titleIV)
- your financial aid package exceeds the amount of your outstanding charges
- you have completed and submitted the BLOC application (<u>www.utica.edu/sfsforms</u>)
- all verification requirements are complete

All books should be ordered for all sessions at the beginning of the semester.
