



## Utica College Payment Guide On-line/ABSN Students FALL 2019

Utica College's Payment Plan for online students allows you to pre-register for all Fall sessions (D1, D2 and D3 – if applicable), and pay your tuition in four scheduled installments (see calendar below). **There is no charge to enroll in the Payment Plan!**

BLOC opens	August 5	3 <sup>rd</sup> Installment due	October 26
Payment in Full Due	August 26	D1 Session ends	October 25
1 <sup>st</sup> Installment due	August 26	D2 Session begins	October 28
D1/D3 Session begins	September 2	4 <sup>th</sup> /Final Payment due	November 15
BLOC Closes	September 26	D2/D3 Sessions end	December 15
2 <sup>nd</sup> Installment due	September 21		

If payment in full or an active and up-to-date payment plan is not in effect by **October 30, 2019**, you may be assessed a **\$50 late fee**. In addition, a hold may be placed on your account which may prevent you from registering for Spring 2020.

### **Set Up Your Payment Plan**

**\*Our secure payment site CANNOT do automatic payments from your bank account nor your credit card. You must go into the payment site and initiate the payment each time. It will, however, give you the option to save your bank account or credit card information if you wish to do so.**

### **Health Insurance Waiver (*\*If Applicable*)**

All full-time students are required to carry Health Insurance. A charge of \$789.75\* will be applied to your bill at the time of full-time registration. If you have private health insurance, and wish to waive the charge from your bill, you must log on to: <http://www.haylor.com/college/utica-college>. **The waiver period opens on June 1, 2019 and the deadline to waive the charge is September 1, 2019.** Please note that information you provide regarding your insurance will be verified. Students who have been found to not have health insurance will automatically be re-enrolled in UC's Health Plan and will be charged accordingly.

### **Opening a Book Line of Credit (BLOC)**

You can open a Book Line Of Credit (BLOC) for the semester if:

- you have filed a valid 2019-2020 FAFSA ([www.fafsa.ed.gov](http://www.fafsa.ed.gov))
- your Title IV authorization has been completed and accepted ([www.utica.edu/titleIV](http://www.utica.edu/titleIV))
- your financial aid package exceeds the amount of your outstanding charges
- you have completed the BLOC request through bannerweb (<http://bannerweb.utica.edu/>)
- all verification requirements are complete

All books should be ordered for all sessions at the beginning of the semester.
