

# Utica College Payment Guide Main Campus Students FALL 2019

Utica College's Payment Plan for Ground Undergraduate students allows you to pre-register for Fall and pay your tuition in five (5) scheduled payments (see calendar below). There is a \$75 fee to enroll in the Payment Plan.

#### **Fall 2019 Semester Dates**

June 10 3<sup>rd</sup> Installment due Health Insurance Waiver opens September 1 Deadline to Waive Health Insurance 1st Installment due September 15 July 1 Payment in Full Due August 1 4th Installment due October 1 2<sup>nd</sup> Installment due August 1 5<sup>th</sup>/Final Payment November 1 Classes Begin September 2 Spring Registration Begins November 18 Classes End December 15

If payment in full is not made by **November 1, 2019**, you may be assessed a **\$50 late fee**. In addition, a hold may be placed on your account which may prevent you from registering for Spring 2020.

#### Set Up Your Payment Plan

- If you elect to pay your balance in full, please click \* Make Payment.
- If you opt for the Payment Plan for the Fall 2019 Semester, please click \*Enroll in the Fall 2019 U Campus Payment Plan. Please note, enrollment in the Fall Payment Plan opens on June 1, 2019.

\*Our secure payment site **CANNOT** do automatic payments from your bank account nor your credit card. You must go into the payment site and initiate the payment each time. It will, however, give you the option to save your bank account or credit card information if you wish to do so.

#### **Health Insurance Waiver**

All full-time students are required to carry Health Insurance. A charge of \$789.75\* will be applied to your bill at the time of full-time registration. If you have private health insurance, and wish to waive the charge from your bill, you must log on to: <a href="http://www.haylor.com/college/utica-college/">http://www.haylor.com/college/utica-college/</a>. The waiver period opens on June 10, 2019 and the deadline to waive the charge is September 1, 2019. Please note that information you provide regarding your insurance will be verified. Students who have been found to not have health insurance will automatically be re-enrolled in UC's Health Plan and will be charged accordingly. \*Health Insurance fee subject to change

## Opening a Book Line of Credit (BLOC)

## You can request a Book Line of Credit beginning August 5 - September 16, 2019

To open a Book Line Of Credit (BLOC) for the semester you must have:

- filed a valid 2019-2020 FAFSA (www.fafsa.ed.gov)
- your Title IV authorization has been completed and accepted (<a href="www.utica.edu/titleIV">www.utica.edu/titleIV</a>)
- your financial aid package exceeds the amount of your outstanding charges
- completed the BLOC request (<a href="http://bannerweb.utica.edu">http://bannerweb.utica.edu</a>)
- all verification requirements are complete

All books should be ordered for all sessions at the beginning of the semester.
