



Utica College Payment Guide On-line/ABSN Students Spring 2021

Utica College's Payment Plan for online students allows you to pre-register for all Spring sessions (D1, D2 and D3 – if applicable), and pay your tuition in four scheduled installments (see calendar below). **There is no charge to enroll in the Payment Plan!**

If payment in full or an active and up-to-date payment plan is not in effect by **January 2, 2021**, you may be assessed a **\$50 late fee**. In addition, a hold may be placed on your account which may prevent you from registering for Summer and/or Fall 2021.

***Our secure payment site CANNOT do automatic payments from your bank account nor your credit card. You must go into the payment site and initiate the payment each time. It will, however, give you the option to save your bank account or credit card information if you wish to do so.**

Health Insurance Waiver

All ABSN students are required to carry Health Insurance. A charge of \$622.00 will be applied to your bill at the time of registration. If you have private health insurance, and wish to waive the charge from your bill, you must log on to: <http://www.haylor.com/college/utica-college>. **The waiver period opens on December 1, 2020 and the deadline to waive the charge is January 26, 2021.** Please note that information you provide regarding your insurance will be verified. Students who have been found to not have health insurance will automatically be re-enrolled in UC's Health Plan and will be charged accordingly.

All Access Book Fee (Applies to Undergraduate D and E Campus Students Only)

With the All Access Book Bundle, [all your text books will be bundled](#) and waiting for you when you arrive. Students may choose to opt-out by logging into bannerweb > Student Services > Opt-Outs > Select Term > Select Opt-Out All Access Book Fee. **Deadline to opt-out is January 22, 2021**

Opening a Book Line of Credit (BLOC)

You can request a Book Line Of Credit (BLOC) for the semester if:

- you have filed a valid 2020-2021 FAFSA (www.studentaid.gov)
- your Title IV authorization has been completed and accepted (www.utica.edu/titleIV)
- your financial aid package exceeds the amount of your outstanding charges
- all verification requirements are complete

If you did not opt-out of the All Access Book Fee, you do not need to submit a BLOC request.
